## Invitation for Sealed Bids for procurement of Fabricated Steel Parts for Trail Bridges

- 1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Aamachhodingmo Rural Municipality for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
- 2. The Aamachhodingmo Rural Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

- Bidding documents may be purchased from the office of Aama Chhodingmo Rural Municipality, Goljungbeshi, Rasuwa by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table, until the (last date of purchase of bidding document) 2076/01/22 from the first date of publication of this notice.
- 6. Bids must be submitted to the office of Aamachhodingmo Rural Municipality, Goljungbeshi, Rasuwa., on or before 2076/01/23, by 12 PM. Documents received after this deadline shall not be accepted.
- 7. Bids will be opened in the presence of Bidders' representatives who choose to attend at Aamachhodingmo Rural **Municipality** on **2076/01/23 by 2 PM** at the office of Aamachhodingmo Rural Municipality, Bids must be valid for a period of **45 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5 % of the quoted Bid amount (inclusive of VAT)**, which shall be **valid for 30 days** beyond the bid validity period.
- 8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No. 0800035173400003 Aamachhodingmo Rural Municipality, Dharauti Account Maintained at Kumari Bank Limited, Chilime Rasuwa and submit bank deposit voucher along with the bid.
- 9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
